4. The following document should be attached at the time of submission of the tender
 - a. Duly filled up BOQ along with sealed and signed of the contractor.
 - b. Valid registration certificate with the concerned authority.
5. Each tender shall be accompanied by Demand draft/cheque as an earnest money deposit for an amount of Rs. 16,000.00(Rupees sixteen thousand) only drawn in favour of the Dean, College of Post Graduate Studies, Umiam, Ribhoi District, Meghalaya, Payable at SBI ICAR Branch.
6. Any tender received without an EMD shall not be entertained and summarily rejected.
7. The Dean of the college reserves the right to accept or reject any of the tender if it is found to be improper and incomplete without assigning any reason thereof which shall be final and binding.
