1. Two bid system. **Sealed envelope - 1** for techno commercial documents and **Sealed envelope-2** for Price bid.
2. Bidder should submit valid licence to work in Meghalaya, GST, PAN and any documents required for execution of the work and having registered under PWD/CPWD/Other govt. agency.
3. All the paper attached with the tender documents are to be sealed and signed by the contractor, the sealed envelope address to the Dean, CoA, Kyrdemkulai, should be superscribed as **"Face lifting of the college building (Pre-fab structure), CoA, Kyrdemkulai"**.
4. The rate quoted shall be inclusive of all taxes for execution of the work, like supplying and providing the materials, tools and machineries, equipments, charges of labour etc, to be engaged in the work.
5. The following document should be attached at the time of submission of the tender
 - a. Duly filled up BOQ along with sealed and signed of the contractor.
 - b. Valid registration certificate with the concerned authority.
6. Each tender shall be accompanied by Demand draft as an Earnest money deposit (EMD) for an amount of **Rs.12,000 /- (Rupees Twelve thousand)** only drawn in favour of the Dean, College of Agriculture, Kyrdemkulai, Ri-bhoi District, Meghalaya, Payable at SBI Umsning Branch in the envelope containing technical bid.
7. Any tender received without an EMD shall not be entertained and summarily rejected.
8. The Dean of the college reserves the right to accept or reject any of the tender if it is found to be improper and incomplete without assigning any reason thereof which shall be final and binding.
9. It may also be noted that, they are liable to be disqualified at any stage during tendering process, in case any of the information furnished by them or the party is found to be false.

12. Successful contractor/firm should complete the work within 30 (thirty) days from the date of award of the work.


