

1. Sealed Tenders are invited by the College of Horticulture & Forestry, Pasighat for Annual Rate Contract (2025-26) for the supply of Lab Items (Chemicals & Glasswares).
2. The envelope containing tender should be super subscribed as **"TENDER FOR LABORATORY CHEMICALS & GLASSWARES ITEMS"** of the top of the envelope.
3. The basic price rate of every item should be inclusive of GST.
4. Discount: Maximum / reasonable discount allowed _____.
5. **FOR: Central Purchase Section, College of Horticulture & Forestry, Pasighat without any extra charges.**
6. Authorized dealers/ distributors must submit valid authorization certificate from manufacturer to sale the Lab items.
7. The material should be supplied as per specification. The sub Standard materials will be summarily rejected.
8. The rate should be valid for the financial year and it may be extended on mutual agreement.
9. The Tender so submitted shall be governed by the GFR rules. In term of GFR rule, tenderers may face legal action, if they amend tender, impair or derogates from the tender in any respect with the period of validity of this tender.
10. The taxes which are not quoted in tender by the supplier will not paid by the University under any circumstances.
