Terms and Conditions of Annual Rate Contract Proposal 2026-27 for supply of laboratory consumables (Chemicals/Plasticware/Glassware/ Other Consumables)

1. Supply must be made by self or through the authorized distributor as indicated in the rate contract document.
2. Company should indicate only one authorized dealer (past reputation must be considered) while submitting quotation. Quotation with more than one authorized dealer will be rejected.
3. Delivery should be made within 20 days from the date of supply order and the price (inclusive of discount) should be in Indian currency.
4. Place of delivery is College of Post Graduate Studies in Agricultural Sciences (CPGSAS), CAU (Imphal), Umroi Road, Umiam (Barapani)-793103, Meghalaya
5. Submission of company printed price catalogue is mandatory and failing to submit the same will lead to rejection of the quotation.
6. Discount as per the rate given during submission of rate contract or more.
7. Defective supply if any, must be replaced and any damage occurring due to defective materials should be compensated and the amount recoverable from the pending bill. The contract is also liable for cancellation if defective/ sub-standard/spurious materials are supplied.
8. The materials ordered for door delivery at CPGSAS only.
9. GST should be specified properly for the heads including laboratory chemicals.
10. Part supply shall not be accepted until and unless it is supported by convincing reasons.
11. Fluctuation in price: The price listed (price list) articles shall remain stable throughout the contract period. Any variation in price of the articles shall have to be passed on to CPGSAS, (CAU), Umiam (Barapani)-793103 (Meghalaya).
12. The Dean, CPGSAS, (CAU), Umiam (Barapani)-793103, Meghalaya reserves the right to cancel the rate contract at any time without assigning any reason by giving one month notice.
