4. Candidates who have attained **16 years** of age as on **31st August, 2026** [for B.Sc. (Hons.) Agriculture/ Horticulture/Natural Farming/ Forestry/ Community Science/ Food Nutrition & Dietetics); B.Tech. (Agril. Engg/ Food Tech.) and BFSc programmes] and minimum age of **17 years** of age as on or before **31st December, 2026** (for B.V.Sc. & AH programme) are eligible to apply. No relaxation is permissible regarding the minimum age limit.

3. All information/communication will be sent through e-mail or mobile no.

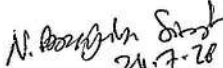

Step-V	After filling the form, make payment of fee using Online Payment Method and keep proof of fee paid
Step-VI	Print a copy of Confirmation Page after successful remittance of fee and save the System Generated Application No. for future references.

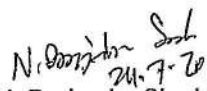

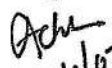
